This document sets out the terms and conditions on which the Agent may act in respect of my aforementioned account with InterTrader Limited/Intertrader Black (the "Account") with full unrestricted and unconditional power and authority to trade on the Account and to do and/or omit to be done all acts and things in relation to the trading activity on my Account unless otherwise specified in this letter.

The actions by the Agent may include, without limitation:

- opening, editing and closing all bets, trades, orders and positions on the Account of any type on behalf of the Client whether attached or not to any existing open bets on the Account;
- to set, edit and delete all dealing preferences relating to the Account on behalf of the Client, for example but without limitation, enabling trailing stops;
- communicate with the Intertrader Limited/Intertrader Black on behalf of the Client regarding any complaints or disputes that the Client may have against InterTrader Limited/Sigma Trading regarding the Account; and
- to accept any amendments to the Intertrader Limited's terms of business, including the Intertrader Limited's Customer Agreement, on behalf of the Client.

Granting of this Power of Attorney by the Client in favour of the Agent is conditional on and to each of the below terms;

- the granting of the authority hereunder to the Agent will be effected only upon the satisfactory identification and verification of the Agent's identification and proof of address by Intertrader Limited/Intertrader Black;
- InterTrader Limited/Sigma Trading not being required or obliged to make any enquiry of the Client or Agent in connection with any instruction received by the Agent on behalf of the Client;

- unless otherwise informed by the Client, Intertrader Limited/Intertrader Black may communicate directly with the Agent regarding the Account. This letter of appointment confirms the Client's consent to any communications made by the Agent to Intertrader Limited/Sigma Trading in respect of the Account and as such, communications made by the Intertrader Limited/Intertrader Black to the Agent are deemed to be received by the Client at the same time they are delivered to the Agent;
- the Client hereby authorises Intertrader Limited/Intertrader Black to disclose all information held in relation to the Account including, without limitation, any personal information relating to the Client, to the Agent and any historical information;
- by providing the Agent with access to the Account, the Client accepts the full responsibility for the instructions given by the Agent to InterTrader Limited/Intertrader Black and any losses that may be incurred upon the Account;
- the Client may revoke this agreement at any time by notifying Intertrader Limited/Intertrader Black in writing of such revocation, however, Client will remain liable for all actions of the Agent until Intertrader Limited/Intertrader Black has confirmed receipt of the Client's revocation.
- acting in absolute discretion, Intertrader Limited/Sigma Trading may decide that it will no longer accept any instructions from the Agent in relation to the Account. Reasonable notice will be given by Intertrader Limited/Intertrader Black to the Client either directly or through the Agent. For regulatory reasons Intertrader Limited/Intertrader Black may not specify the reasons behind the discontinuation of its acknowledgement of this agreement;
- this Deed shall be governed by and construed in accordance with the laws of Gibraltar, and by signing this agreement all parties irrevocably submit to the jurisdiction of the Gibraltar Court in relation to any dispute arising from this Deed; and
- Intertrader Limited/Intertrader Black will accept receipt of this Deed via scanned copy and delivery at its offices of the original signed copy.
